Construction is now vertical at the Valley Ranch Town Center in Porter. Officials with the East Montgomery County Improvement District and The Signorelli Company held a groundbreaking ceremony for Academy Sports + Outdoors Tuesday, April 5. Construction on the sports, outdoor and lifestyle center began, however, in March. It joins the Kroger Marketplace and Sam's Club as anchor stores for the 1.8 million square foot mixed-use development at the Grand Parkway and Interstate 69.

Additional tenants, including Chickfila, Chili's, El Pollo Loco, Freebirds, GNC, Nails of America, SportClips, Subway, Supercuts, and T. Jin's Asian Café, have been secured for the 240-acre property, with additional shopping, dining and entertainment venues to be announced in the next few months.

In a move designed to encourage additional job opportunities for residents in East Montgomery County, EMCID's Board of Directors agreed to provide space for interviews and applicant screening for Academy's growth.

"As other tenants secure retail space, our Board will ensure that employment/interview facilities are available within the district's boundaries to ensure the greatest utilization of local residents for these employment opportunities," said Frank McCrady, President and CEO.

Growing Our Own

Completing 28 years in the Army Reserve and retiring as a Lieutenant Colonel has provided keen insight into the importance of leadership development. The Command General Staff College and Army War College courses pointed out valuable lessons to me which apply to today's workforce and even our areas of development. EMCID Recruits Ammunition Manufacturer to Industrial Park in Joint Economic, Community Development Venture

General Ballistics, a California-based ammunition manufacturer founded by Vance Massih, will expand into the Texas market in a deal crafted by the East Montgomery County Improvement District that will also benefit local law enforcement. The Board of Directors agreed to build a 10,000-square foot production facility and qualification range at the East Montgomery County Industrial Park and lease it to General Ballistics. The company will produce 9 mm, .40-caliber, .45-caliber and 5.56/.223-caliber cartridges. Initially, the company will employ two to three people upon opening in January of 2017.

Frank McCrady, President and CEO of EMCID, spent the past year talking with local law enforcement agencies about the need for a qualification range in East Montgomery County that they can utilize for training purposes.

"Through our conversations with the agencies, the general consensus was that there's a potential for cost savings for the agencies in the areas of manpower and fuel, and a reduction in the time officers spend away from work," said McCrady. "In constructing a dual purpose facility which can be used by the company and for local law enforcement needs really fits the model for an economic development/ community development project."

SpeedSportz Racing Gears Up for Action





The co-owner of SpeedSportz Racing Park gave an update in March to local business leaders regarding construction of the European-style kart racing attraction along State Highway 242 and U.S. Highway 59.

Alan Rudolph told the crowd at the Greater East Montgomery County Chamber of Commerce's The Loop that completion is scheduled for Labor Day weekend. The park will feature two tracks, one for professionals and one for guests who want to zip along at speeds of 40- to 60-mph. The property will also feature video games in an arcade, meeting spaces for corporate events, and a pro-shop retail center.

EMCID Makes a SPLASH in Roman Forest, Splendora



EMCID is delivering some outdoor fun for children in East Montgomery County with the addition of splash pad parks in the cities of Roman Forest and Splendora! The Board of Directors agreed during last year's strategic planning session to be involved in a large community project that would benefit thousands of children within the district. A comprehensive study determined the best locations for the parks. The Board then chose Kraftsman Playground and Park Equipment out of Spring, TX to build and install the splash pads.



"The Board is really excited about this project," said Frank McCrady, EMCID President and CEO. "Researching other sites in the Houston area and evaluating their positive and negative attributes helped our Board in its decision-making process."

Construction on Splendora's park should be completed this summer. Roman Forest's splash pad park will be constructed in mid- to late summer. EMCID is spending approximately \$450,000 on each splash pad. The cities have agreed to maintain and operate the parks.

EMCID Board Approves Additional \$1.5 Million in Grants For East Montgomery County Fire Department, Improvements to Fire Station

The Board of Directors of the East Montgomery County Improvement District authorized in March the issuance of \$300,000 annually, retroactive to 2015 and through 2019, to the Montgomery County Emergency Services District #7 (MCESD #7), also known as the East Montgomery County Fire Department, which serves New Caney and Splendora. The measure stipulates that the fire department utilize the first payment to upgrade to code Fire Station #156 on Morgan Cemetery Road in Splendora — which is not currently providing 24-hour service or staffing — to make it ready for full-time staffing, at a cost of about \$56,000. Approximately \$125,000 would pay for about 15 self-contained breathing apparatus systems for firefighters, and the balance of the funds would be utilized to buy other necessary equipment and improvements to the station to ensure it is operational 24 hours a day.

"The Board feels very strongly about doing what it can to ensure the safety of the residents and firefighters in East Montgomery County," said Brenda Webb, Chairman of the Board. "We admire the dedication our firefighters have to this community, and we want them to have the tools necessary to do their jobs."

EMCID President and CEO Frank McCrady said having the fire station on Morgan Cemetery operational was of utmost

importance to everyone. "Quicker response times saves lives. We're happy to help get this facility open and fully staffed," he said. "Our funding priorities have always been in line with providing this community what it needs to improve the quality of life here in East Montgomery County."

Additionally, the funding measure would require MCESD #7 to reimburse EMCID the cost of the upgrades to Fire Station #156, or about \$56,000, in the event the City of Cleveland annexed the property, bringing this funding back into the EMCID territory to be utilized by the East Montgomery County community.

Mission Northeast's Capacity to Serve Others Grows

Mission Northeast celebrated the opening of its new 5,000-square foot storage warehouse in New Caney at a ribbon cutting ceremony March 22. The building, which includes a 16-by-20 foot walk-in freezer and a 16-by-20 foot walk-in cooler, replaces the previous warehouse, which only had a 5-by-8 feet freezer. That building will now be used for other services and office space. EMCID provided a grant for \$49,010.50 to go toward construction costs.

Pam Dickson, Director of Mission Northeast, said the organization will be able to better serve its clients throughout the year and the 500 families during Thanksgiving and Christmas who depend on the Mission for assistance.

Each year EMCID has donated turkeys and hams to the Mission a week or so before Christmas. Those items could barely fit into the smaller freezer. Now, Dickson says, those items could be donated several weeks in advance, and there would still be available freezer space for other donated food items.

Mission Northeast provides a wide variety of services to more than 150 families per week from 11 zip codes.
