German native Holger Butzelar arrived in the area about 10 years ago and has managed to carry over the success of his classic car/parts sales and hot rod business in Europe across the pond to East Montgomery County doing business as New Caney Customs LLC.

He has mainly continued to export classic American cars and sell parts online because he operates out of his home.

"I specialize in hot rod parts for cars from 1930 to 1980. I keep all steering, lights and engine accessories in stock and can say that no one else has the inventory I have," he says. "I go to almost all of the big swap meets in Texas with my trailer set up."

There's just one problem, he says.

"I need a store front, displays, and space for the customer who wants to come in and buy items on the spot. There are a few small shops that can order parts, but no one has the stock I have in a radius of at least 250 miles."

He's getting that needed space at the East Montgomery County Industrial Park.

"Holger's got an amazing business exporting cars and parts to buyers across the globe," said Frank McCrady, President and CEO of EMCID. "EMCID saw an opportunity to help expand the success of his business with the addition of a store and warehouse where people can actually take a look at all he has to offer. That's what we're here for."

The East Montgomery County Economic Development Corporation, a subsidiary of EMCID, provided low interest financing for the construction of a facility. Butzelar expects to move to his new location by late summer.

Board Awards \$201,007.73 in Fall Grants, Proposes Changes to Grant Criteria for Spring

The Board of Directors presented checks in December 2016 and February 2017 to 15 agencies and organizations for 18 community development grants totaling \$201,007.73. The grants were approved at the Board's regular meetings in November and January. Grants are funded twice a year to governmental entities and non-profit organizations for projects that improve the quality of life for residents in East Montgomery County. Mini grants are available for up to \$5,000 and require no match from the organization. Regular grants are available for up to \$30,000. Non-profit applicants of this type of grant must have at least 33 percent matching funds for their projects; taxing entities must have at least 50 percent of matching funds.

The total 2016-2017 community development grant budget is \$250,000.

The Board of Directors implemented changes to the grant program, which may be found in detail on the application, available online at www.emctx.com or in the office. Applications for the Spring grant cycle are due by March 27 at 5 p.m.







Safe Shopper Program Deters Shoplifting, Allows Opportunity for More Felony Arrests

EMCID and the Constable's office teamed up for a fifth year to provide additional security at high traffic shopping areas during the holiday shopping season, from October 15, 2016 to January 31, 2017, as part of the Safe Shopper Program. The Board approved \$50,000 for extra patrols.


Deputies arrested 28 shoplifters, 35 people on misdemeanor charges and 66 people for felonies through January 11*, or over an 89-day period. In the first year of the program, over a 29-day period in 2012, deputies arrested 26 shoplifters, 36 people on misdemeanors and 12 people for felonies. When averaged out over a similar time span, that equals a 34 percent decrease in shoplifting occurrences, a 31 percent decrease in misdemeanor arrests and a 180 percent increase** in felony arrests over the past five years.

EMCID Presents Check to ESD #7



The Board presented a check in January for \$300,000 to Chief Howard Rinewalt and ESD #7 President Jan Peterson on behalf of the East Montgomery County Fire Department. The funds are part of EMCID's continued support of ESD #7 and expanded fire protection for residents in New Caney and Splendora.

Local Businesses, Community Leaders Support Scholarships Through Foundation

Businesses and the community came together in November to celebrate the success of the East Montgomery County Scholarship Foundation's (EMCSF) work to provide every high school graduate in East Montgomery County a scholarship. A gala, featuring two scholarship recipients as guest speakers, was held at the EMCID Complex November 1. To date, the EMCSF, which is a non-profit charitable organization under EMCID's umbrella, has paid out more than \$2.8 million in scholarships since its inception.

The EMCSF gives \$1,000 scholarships to all graduating seniors from New Caney ISD and Splendora ISD, along with those who graduate from private school, home-school programs or get a GED.

In addition to the \$1,000 scholarship awarded to local graduates, EMCSF offers a \$500 merit-based scholarship to college students and a \$750 internship program.

"Because of the participation of all the past and present donors, the EMCSF is excited about the growing and expanding minds of the future leaders of our community and this great nation," said Brenda Webb, Chairman of the Board.

Megan Silva Hartwick, a 2010 New Caney High School graduate and 2015 Lamar University masters degree recipient, and Nia Ramirez, a 2012 Splendora High School graduate and current undergraduate at Sam Houston State University, spoke at the gala about the opportunities afforded to them through the financial assistance from the EMCSF.
