
The meeting will be held on **Thursday, August 14, 2025, at 5:30 p.m.** The Board shall act upon the following matters:

1. Consider comments from members of the audience (Please note that the Board imposes a three-minute speaking limit for each member of the public wishing to address the Board; comments will be closed after this item);
2. Approval of the minutes of the Board of Directors meetings held on June 12, 2025, July 10, 2025, and July 24, 2025;
3. Status of construction of improvements and the leasing of space in The Atrium Center, and the taking of any actions required in connection therewith;
4. Consider request from Montgomery County Sheriff's office for funds to purchase equipment for its newly formed traffic division, and the taking of any actions required in connection therewith;
5. Consider financial, bookkeeping, cash flow and investment reports, and the taking of any actions required in connection therewith, and authorizing the payment of invoices presented or shown in such reports;
6. Consider review of Façade Improvement Grant Program requests and approval of funding in connection with same;
7. Consider report on District engineering and construction projects in the Industrial Park, including:
  - a) Status of sale of dirt from future detention pond, and the taking of any actions required in connection therewith;
8. Consider status of development of the East Montgomery County recreational park, including:
  - a) Status of service agreement with Burditt Consultants, LLC, for Phase I Park Improvements including design and construction services for the dog park, parking, prefabricated restrooms and landscaping; and
  - b) review bids and authorize award of contract for the site preparation to serve the Phase I Park Improvements, and the taking of any actions required in connection therewith;

Recess and reconvene in Executive Session to discuss real property matters pursuant to §551.072, Texas Government Code, matters in which the duty of the attorney to the District under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflict with Chapter 551, Texas Government Code, pursuant to §551.071, Texas Government Code, Economic Development negotiations pursuant to §551.087, Texas Government Code, and personnel matters pursuant to §551.074, Texas Government Code, and reconvene in Open Session;
11. Approval of Fifth Amended and Restated Agreement with the Greater East Montgomery County Chamber, and the taking of any actions required in connection therewith;
12. Status of economic development agreements and take actions required in connection with the following:
  - a) Approval of Incentive Agreement with Beck International;
  - b) Status of Incentive Agreement with Uncle Tony's Café;
  - c) Status of Incentive Agreement with CC SCOA III, LP; and
  - d) Status of Incentive Agreement with Dhanani Private Equity Group;
13. Consider report on activities and real property transactions within the Industrial Park and take appropriate action related to the following:
  - a) Authorize purchase of approximately 0.1924 acres along Nichols Lane relative to expansion of Industrial Park and obtaining roadway frontage;
  - b) Authorize the sale or lease of property in the Industrial Park for telecommunications use;
  - c) Approval of Purchase and Sale Agreement and related incentives relative to the sale of land in the Industrial Park to Catalyst Trading or assignees, including authorizing the Chair and President/CEO to take all actions necessary to close on the land transaction;
  - d) Status of contracts for the purchase of land for expansion of the Industrial Park;
  - e) Status of Purchase and Sale Agreement and related incentives relative to the sale of land in the Industrial Park to GCP Paper USA, Inc.;
  - f) Status Purchase and Sale Agreement and related incentives relative to the sale of land in the Industrial Park to Tension Steel Pipe Corporation USA;
  - g) Status of Purchase and Sale Agreement and related incentives relative to the sale of land in the Industrial Park to Milestone Metals or assignees;
  - h) Status of Purchase and Sale Agreement and related incentives relative to the sale of land in the Industrial Park to Master Fans de Mexico or assignees; and
  - i) Status of modification to Gates Lubricants Agreement and related documents;
14. Consider approval of Lease Agreement between the District and Elevated Land Solutions for the lease of space in the EDA Building;
15. Status of contract with Spaw-Glass Construction Corporation for construction of the conference center, and authorize the taking of any actions required in connection therewith;
