

NOTICE OF ELECTION

TO THE DULY QUALIFIED RESIDENT VOTERS OF EAST MONTGOMERY COUNTY IMPROVEMENT DISTRICT:

Notice is hereby given that the East Montgomery County Improvement District (the "District") will hold an election on May 2, 2026, to elect Directors to Director Position Numbers 5, 6, 7 and 8 for the Board of Directors of the District.

Early voting by personal appearance shall be conducted at the dates, times and locations listed on **Exhibit "A"** attached hereto and incorporated herein for all purposes. During the early voting period, registered voters of the District may vote at any of the polling locations listed on **Exhibit "A"**.

Voting on Election Day shall be held on May 2, 2026, from 7:00 a.m. to 7:00 p.m. On Election Day, voters of the District must vote at the consolidated polling location designated for the precinct in which they are registered to vote. Pursuant to an order adopted by Montgomery County, the following seven (7) consolidated polling locations will serve as the precinct voting locations for voters within the District:

1. Allendale Baptist Church (Fellowship Hall) located at 14535 Allendale Lane, Conroe, Texas, 77302 (*Precincts 36 and 64*);
2. East Montgomery County Fair Association Building (Main Room) located at 21675A McCleskey Road, New Caney, Texas, 77357 (*Precincts 07, 26, 52 and 93*);
3. East Montgomery County Community Development Center (Hayden and Dunn Conference Rooms) located at 16401 First Street, Suite 100, Splendora, Texas, 77372 (*Precincts 16, 41 and 120*);
4. Lone Star College-Kingwood, Performing Arts Center (APA 119) located at 500 Royston Drive, Kingwood, Texas 77339 (*Precincts 37, 82, 94 and 95*);
5. Robert L. Crippen Elementary School (Gym) located at 18690 Cumberland Boulevard, Porter, Texas, 77365 (*Precincts 14 and 118*);
6. Security Community Center (Main Room) located at 18760 Highway 105 East, Cleveland, Texas, 77328 (*Precinct 12*); and
7. Woodbranch City Hall (Meeting Room) located at 58 A Woodbranch Drive, New Caney, Texas 77357 (*Precincts 53, 54 and 119*).

The Early Voting Clerk for the election is Suzie Harvey. Applications for Ballots by Mail may be (i) submitted by regular USPS mail to the Elections Administrator at P.O. Box 2646, Conroe, Texas 77305-2646, (ii) delivered in person or by common or contract carrier to the Elections Administrator at 9159 Airport Road, Conroe, Texas 77303, (iii) sent by email to election.ballot@mctx.org, or (iv) sent by fax to (936) 788-8340. To be effective, an application for ballot by mail submitted by FAX or EMAIL must also be submitted by mail and be received by the Early Voting Clerk at one of the addresses listed in (i) or (ii) above not later than the fourth business day after the date the transmission by fax or email is received. Applications for Ballots by Mail and Federal Post Card Applications must be received no later than the close of business on April 20, 2026.
